# **Latimer House**



### All proceeds from the Western Slope Triple Play benefit Hilltop's Latimer House and those affected by domestic violence.

### **Hilltop's Latimer House**

Latimer House's mission is to "provide opportunities to empower individuals to live violence-free lives." For over 40 years, Latimer House has improved lives by providing emergency shelter, intervention, and treatment for women and children while also helping to prevent abuse through educating the community about its presence, dynamics and treatment.

Latimer House is the only safe house in Mesa County moving those affected by domestic violence and sexual assault "from crisis to confidence."

#### Domestic Violence and Sexual Assault Facts:

- Victims of intimate partner violence lose a total of 8 million days of paid work the equivalent of more than 32,000 full time jobs and nearly 5.6 million days of household productivity each year as a result of abuse
- In 2019, the Mesa County District Attorney's Office reported nearly 830 domestic violence cases
- Victims of abuse often report they return to an abusive situation because they cannot find affordable long-term housing

### **Latimer House Services:**

- Emergency safe house
- Case management and advocacy
- Group counseling
- Children's services
- Transitional housing
- 24-hour crisis line

### **In 2019 Latimer House:**

- Responded to over 2,652 calls from individuals affected by domestic violence and sexual assault through the 24-hour crisis line
- Provided 264 women and children in Mesa County with safe house services
- Offered group sessions, case management, advocacy and counseling to an additional 182 community members
- Raised awareness in our community with 39 presentations about domestic violence and sexual assault
